

# Aichi-Nagoya 2026 Asian Games Additional Ticket Sales (H.K. Region) Application Form (Only applicable to SF&OC & NSA)

## A) Instructions:

1. Application period is from 22 June to 18:00 on 24 June 2026.
2. Applications for Aichi-Nagoya 2026 Asian Games additional tickets shall be submitted by **National Sports Associations (Abbr. NSAs)**. Each NSA shall complete this Additional Ticket Sales Application Form on behalf of its members. The form includes three parts. Please read through this instruction together with the Terms and Conditions before completing the form. Submission of ticket applications shall indicate the affiliated association acknowledge and agree to all these Terms and Conditions of sales.
3. Please fill in the Form in black or blue non-faded pen and write legibly. China Travel Service (H.K.) Limited (Abbr. CTSHK) will not be held responsibility of unsuccessful ticket application due to illegibility.
4. Please complete the form and email us at [ag2026noc@ctg.cn](mailto:ag2026noc@ctg.cn).
5. Ticket Application and Sales is only open to Hong Kong identity card holders aged 18 or above. All applications must be **submitted by NSAs only**.
6. CTSHK will collect personal information after the ticket allocation result is confirmed. The NSA shall list out required event sessions and total ticket quantity, and **provide one representative's contact information as well as credit card details for order guarantee purpose**.
7. CTSHK may forward your personal information collected to the Sports Federation & Olympic Committee of Hong Kong, China (Abbr. SF&OC) and the Aichi-Nagoya Asian Games Organizing Committee (Abbr. AINAGOC) for security reasons. CTSHK is committed to protecting the privacy, confidentiality, and security of the personal information we hold by complying with the requirements of Personal Data (Privacy) Ordinance with respect to the management of personal information. Unless the data subject gives consent otherwise personal data should be used for the purposes for which they were collected or a directly related purpose and kept no longer than necessary.
8. Please provide complete and accurate information for all sections in the form. Please put a "✓" in the appropriate boxes.
9. Please provide a valid Hong Kong telephone number of the representative of the NSA.
10. The application result is expected to be released tentatively around **mid-July**. All notification/ confirmation will be sent via email to individual NSAs.
11. **Important note:** All tickets approved under this application are non-cancellable. For example, if an NSA applies for 30 tickets but is ultimately allocated 12, the allocated tickets must be accepted and cannot be cancelled under any circumstances.
12. In case of discrepancy, the Chinese version shall prevail.

**B) Terms and Conditions:**

1. Each NSA may apply for a maximum of 10 additional events, with a maximum of 30 tickets per event. The computer system will automatically adjust the quantity of tickets based on the above ceiling if the input number is higher than the maximum allowed.
2. If the session date/time/sport/session codes do not tally, CTSHK will take **session codes** as the final request to proceed.
3. If the price category and unit price do not tally, CTSHK will take price category as the final request to proceed.
4. Ticket prices are set by AINAGOC. CTSHK will only accept HKD for transaction.
5. A handling fee approved by AINAGOC will be collected by CTSHK. Ticket prices and handling fees are listed out separately in the “20th Asian Games Aichi-Nagoya 2026 Schedule \_Additional Event” for all additional sessions.
6. All event dates, time, sessions and venues are subject to final confirmation by AINAGOC. Please refer to the official website for details: [www.aichi-nagoya2026.org](http://www.aichi-nagoya2026.org).
7. Approved ticket applications are non-cancellable. Tickets are allocated by AINAGOC. NSAs will receive email if their ticket applications are approved.
8. Please keep all the Notification/Confirmation Letter, Payment Receipt, Ticket Exchange Coupon safe and sound in exchange for the final admission tickets in due course.
9. All ticket purchasers agree that all tickets bought cannot be re-sold or used to promote any person, entity, product or service. Ticket purchasers shall be held responsibility for any violation of these terms.
10. If the Games are cancelled or if AINAGOC ceases to be responsible for organizing the Games, ticket purchasers agree not to bring any claim or take any action for indemnity, damages or compensation against SF&OC, AINAGOC, and CTSHK.
11. Tickets purchased are non-refundable, unless otherwise specified by AINAGOC or the match is cancelled.
12. Any unlisted matter will follow the rules and regulations of AINAGOC.
13. CTSHK has the right to make the final decision in the event of any dispute.
